<u>GRADE:</u> 12 (Salary varies according to jurisdiction)

<u>MINIMUM QUALIFICATIONS</u>: Candidates must have one (1) year of permanent or contingent permanent status in the position of Security Guard in a municipality under the jurisdiction of the Rensselaer County Civil Service Commission immediately preceding the date of examination.

TYPICAL WORK ACTIVITIES: (Illustrative only)

Maintains watch coverage for the building and grounds by scheduling shift and station

assignments, holidays and vacations and by scheduling rounds;

Prepares security plan relating to fire prevention, disaster planning and evacuation of patients and/or staff in case of emergency;

Conducts scheduled and unscheduled fire drills and disaster drills and writes critiques on the effectiveness of same; Investigates thefts and workplace incidents and prepares written reports on findings;

Maintains a daily log noting all unusual matters observed by or reported to subordinates or contracted staff;

Trains, schedules and evaluates receptionists, watchmen and security contracted personnel;

Develops and enforces procedures as they relate to security and life safety;

Provides in service training to facility staff;

Coordinates Criminal History Record Checks on all incoming employees;

Provides identification badges for current employees;

Maintains logs of workplace injuries in compliance with workplace safety regulations;

Ensuring routine maintenance is done on facility vehicles;

Oversight of communication devices including telephone system, cellular phones and radio communications; Performs related duties as required.

<u>SUBJECT OF EXAMINATION</u>: Written test will cover knowledge, skills and/or abilities in such areas as:

- 1. Following directions (maps);
- 2. Principles and practices of safety and security;
- 3. Preparing written material;
- 4. Supervision;
- 5. Understanding and interpreting written material.

GENERAL INFORMATION

- Each candidate must complete an application form and file it with the Rensselaer County Civil Service Commission, County Office Building, 1600 – 7th Avenue, Troy, New York 12180. Applications should be filed as soon as possible after the announcement of examination. When writing for applications, forms or information, SPECIFY BY ANNOUNCEMENT NUMBER AND TITLE of the position for which you wish to apply. You may also obtain an application and examination announcement from the Rensselaer County website at <u>www.rensco.com</u>. BE SURE EVERY QUESTION IS ANSWERED. SUBMISSION OF A RESUME INSTEAD OF A COMPLETED APPLICATION IS UNACCEPTABLE. AN INCOMPLETE APPLICATION MAY BE DISAPPROVED.
- 2. Accepted candidates will be notified when and where to appear for examination. No one will be admitted to the examination without the official admission notice. If an application is rejected, you will be notified in writing. The Civil Service Commission does not make formal acknowledgement of receipt of application. Call the Civil Service Office if you have not received your notice three (3) days prior to the date of examination. <u>NOTICE TO CANDIDATES</u>: Unless otherwise notified, candidates are permitted to use quiet, hand-held solar or battery powered calculators. Cell phone calculators are not permitted. Devices with typewriter keyboards, spell-check, personal digital assistants, address books, language translators, dictionaries or any similar devices are prohibited.
- 3. <u>SENIORITY CREDITS</u> will be added to an eligible score as follows: Using as a basis six (6) months of continuous permanent or contingent permanent service in the jurisdiction for which the eligible list is being established as an equivalent to 0.1. No seniority credit will be allowed for service in excess of twenty (20) years.
- 4. For purpose of claiming veterans credits on a Civil Service examination, an applicant must have received an honorable discharge and have served in the armed forces of the United States at any time during the following periods:

December 7, 1941 to December 31, 1946	June
June 27, 1950 to January 31, 1955	Octo
December 22, 1961 to May 7, 1975	Dec
August 2, 1990 to end of such hostilities	

June 1, 1983 to December 1, 1987* October 23, 1983 to November 21, 1983 December 20, 1989 to January 31, 1990*

*Credit for Lebanon, Grenada and Panama will be limited to those who receive the armed forces expeditionary medal, the navy expeditionary medal or the Marine Corps expeditionary medal.

Veterans wishing to claim additional credit on the examination must make claim when filing application. All veterans making application for additional credit on the examination must file a Photostat copy of their discharge papers with applications. A candidate who fails to establish, by appropriate documentary proof, his eligibility to receive additional credit by the time an eligible list is established shall not, thereafter, be granted additional credit on such eligible list.

Effective January 1, 1998, the State constitution was amended to permit a candidate currently in the armed forces to apply for and be conditionally granted veterans credit in examination. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. No credit may be granted after the establishment of the list. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in Section 85 of the Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credits.

- 5. In conformance with Section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten (10) points in a competitive examination for original appointments in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two (2) months from application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
- 6. This written examination is prepared and rated by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service Law. The provisions of the New York State Civil Service Rules and Regulations dealing with the rating and review of examinations will apply. **VERIFICATION OF QUALIFICATIONS** may be investigated and candidates may be called for an interview to determine whether they are qualified for appointment. You may be required to take a medical examination to determine if you are medically and physically capable of performing the duties of the position. Eligible Lists will be established in order of final rating for successful candidates and will be established for a period of four (4) years or until the establishment of an appropriate new list.
- 7. <u>APPLICATION FEE</u>: A <u>non-refundable</u> fee of \$20.00 is required for each separately numbered examination for which you apply. Certain examinations will require a \$30.00 filing fee. <u>The required examination fee must accompany your application(s) in the form of a Check or Money Order</u> made payable to the Rensselaer County Civil Service Commission and write the examination number(s) on your check or money order. <u>NO CASH ACCEPTED</u>. As no refund will be made, you are urged to compare your qualifications carefully with the requirements for admission and file only for those examinations for which you are clearly qualified.
- 8. <u>APPLICATION FEE WAIVER</u>: A waiver of application fee will be allowed if you are unemployed and primarily responsible for the support of a household. In addition, a waiver of application fee will be allowed if you are determined eligible for Medicaid or receiving Supplemental Security Income payments or Public Assistance (Temporary Assistance for Needy Families/Family Assistance or Safety Net Assistance) or are certified Job Training Partnership Act/Workforce Investment Act eligible through a State or local social service agency. ALL CLAIMS FOR APPLICATION FEE WAIVER ARE SUBJECT TO VERIFICATION. If you can verify eligibility for application fee waiver, you must complete a "Request for Application Fee Waiver and Certification" form and submit it with your application by the close of business on the application deadline as listed on the Examination announcement. You may obtain an Examination Fee Waiver Request and Certification Form from the Rensselaer County Civil Service Office. An application for examination and/or a Request for Application Fee Waiver and Certification.
- 9. <u>Religious Accommodations</u>: Most written tests are held on Saturdays. If you cannot take the test on the announced test date due to a conflict with a religious observance or practice, check the appropriate box under "Religious Accommodations" on your application. We will make arrangements for you to take the test on a different date.
